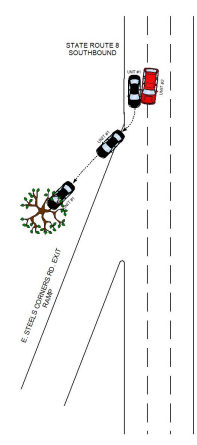

UNIT #1 WAS TRAVELING SOUTHBOUND ON STATE ROUTE 8 IN THE RIGHT-LANE APPROACHING THE EXIT RAMP TO E. STEELS CORNERS RD. UNIT #2 WAS IN THE MIDDLE LANE DIRECTLY NEXT TO UNIT #1. UNIT #2 ATTEMPTED TO MOVE OVER INTO THE RIGHT-LANE AND MADE AN IMPROPER LANE CHANGE. AS A RESULT, THE PASSENGER SIDE OF UNIT #2 STRUCK THE DRIVER SIDE OF UNIT #1. THIS THEN CAUSED UNIT #1 TO DRIVE OFF OF THE

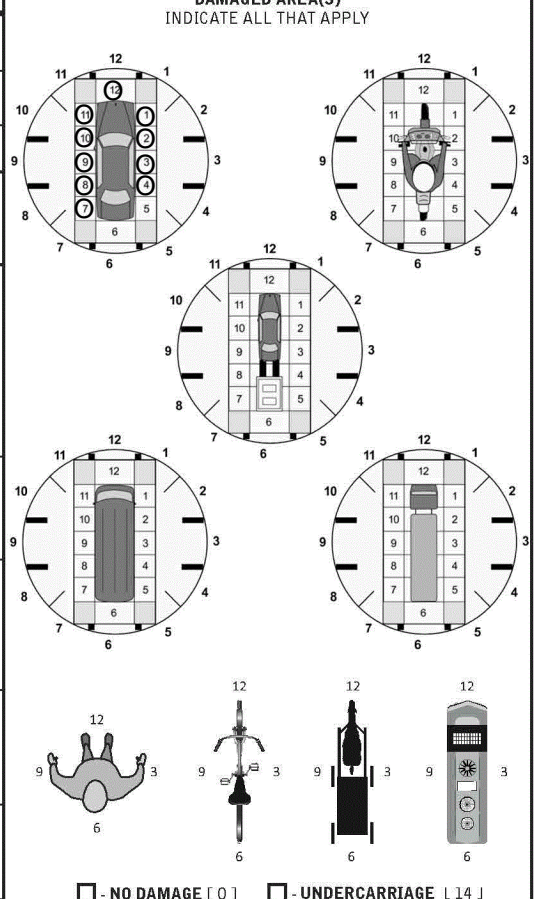

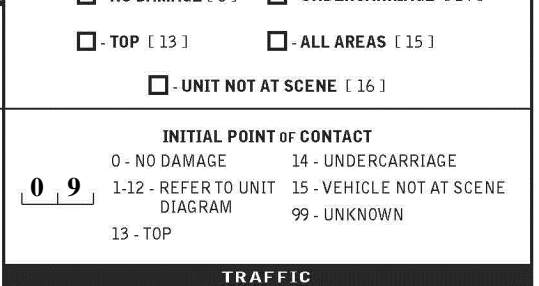
