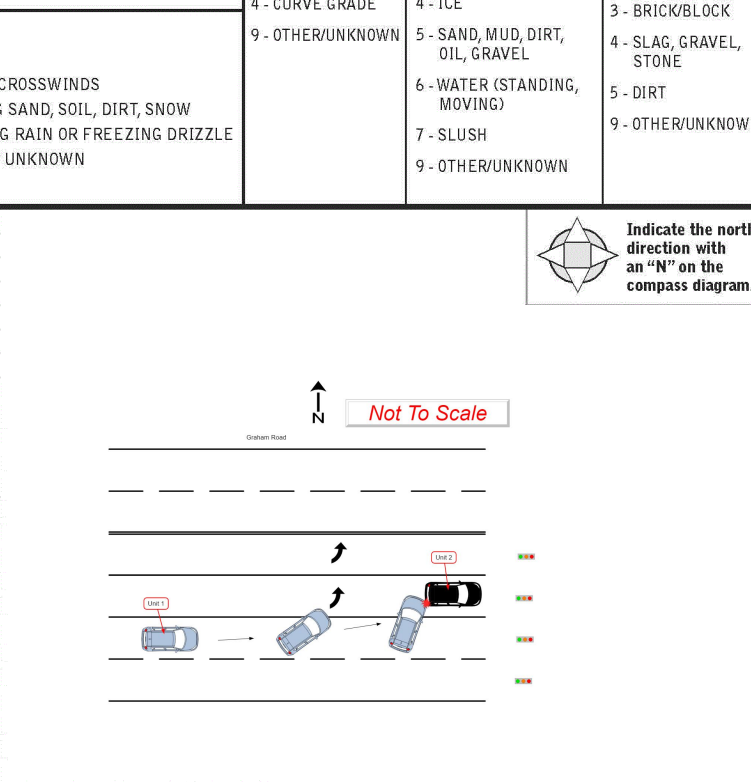

On 2/6/26, the weather conditions were snowy and windy.

Unit 2 was at the intersection of Graham Rd and Darrow Rd. Unit 2 was facing east in the left turn lane on Graham Rd to turn left on Darrow Rd. Unit 1 was traveling east in the left through lane. Unit 1 failed to control the vehicle due to the inclement weather, and drifted sideways. Now traveling east, but facing north and Unit 1 struck Unit 2.

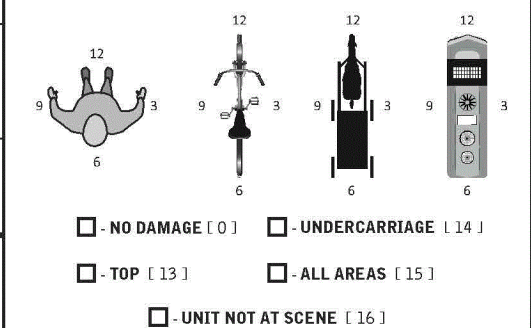

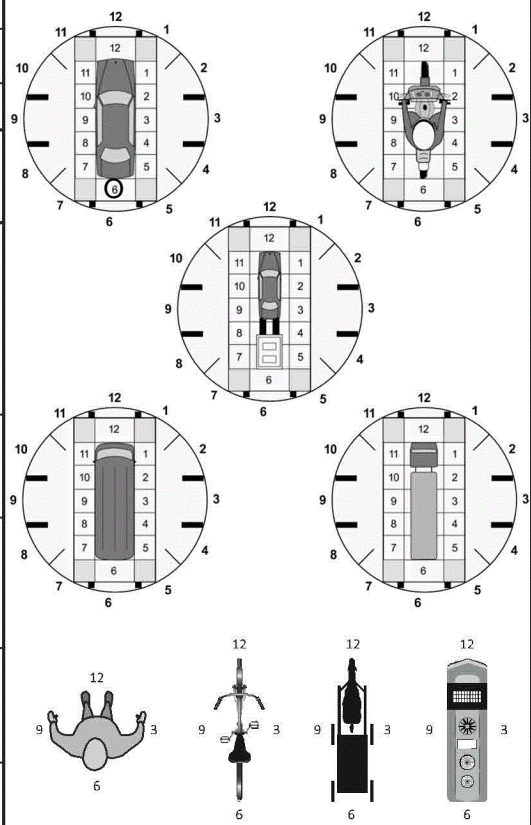
