The two units collided on Seasons Rd at or near the intersection of the SR 8 NB exit ramp. The drivers gave conflicting statements about the condition of the traffic signal at that intersection (each claimed to have a green light). There were no independent witnesses and police

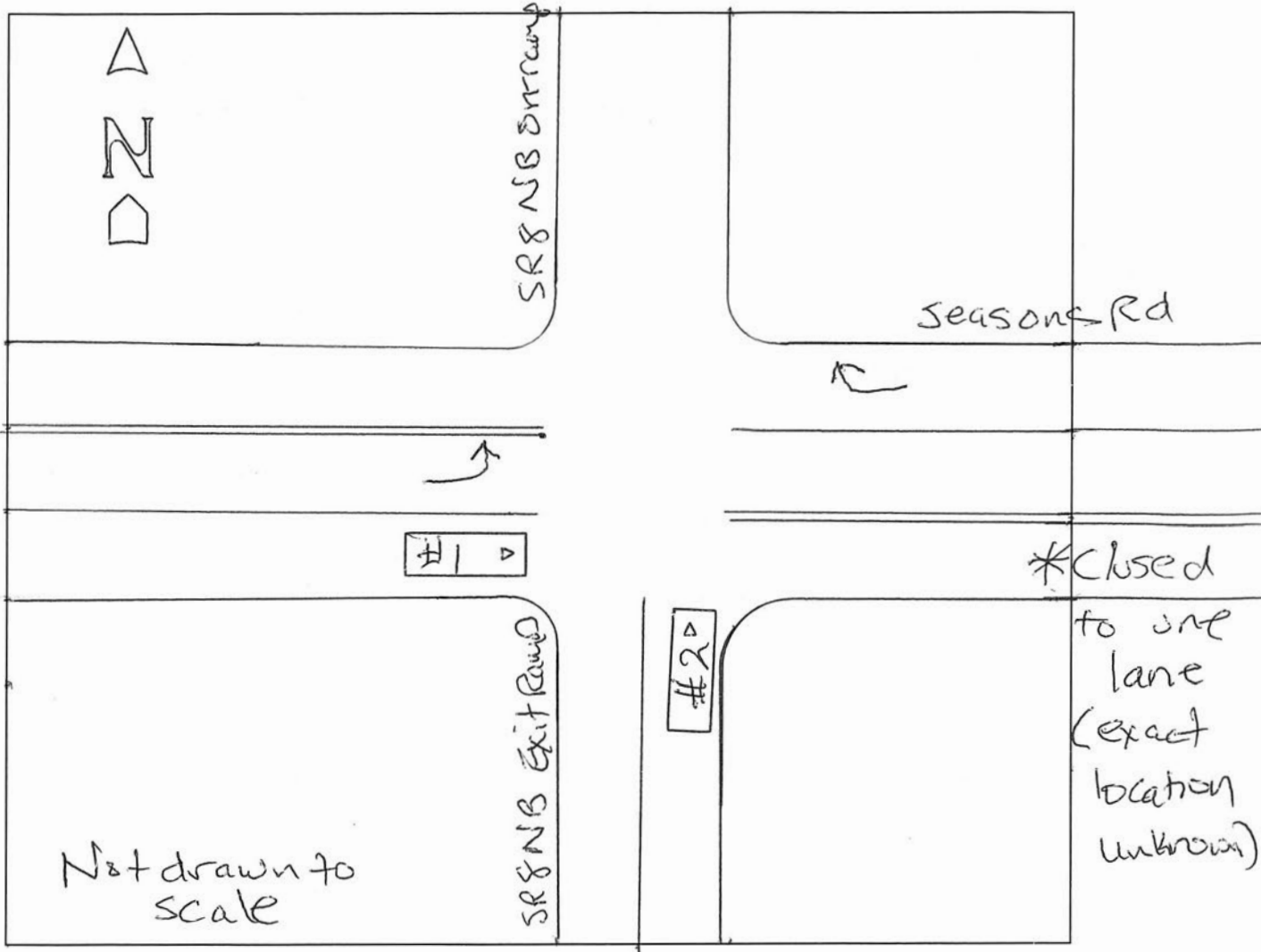

Tuesday 9/6 Approximately 7:55am
 2017 Ford Explorer (dark blue) exited Route 8 north at seasons road exit.
 Stop light at bottom of exit ramp was green, making a right turn onto Seasons Road was prohibited as traffic was stopped and backed up to the off ramp intersection due to the portable/temporary road work stop light was red. This device was located approximately 25-30 yards from the off ramp the traffic signal at the off ramp turned red. My vehicle remained at stop the traffic signal turned green and I slowly began right turn onto Seasons road. My vehicle was at a 45° angle for a few seconds as traffic that was stopped proceeded slowly. I had progressed a few feet and was fully straight in the right lane. A blue nissan sentra (HVB 4609) came along side of me and swerved into my driver side quarter panel. ^{left of center}
 I stopped. The driver of the Nissan stopped, exited the vehicle; claimed it was my fault. Took a picture of my license plate. Got back into the nissan and left the scene.
 I proceeded to place of employment (Kobelco)
 There were no witnesses at the scene.
