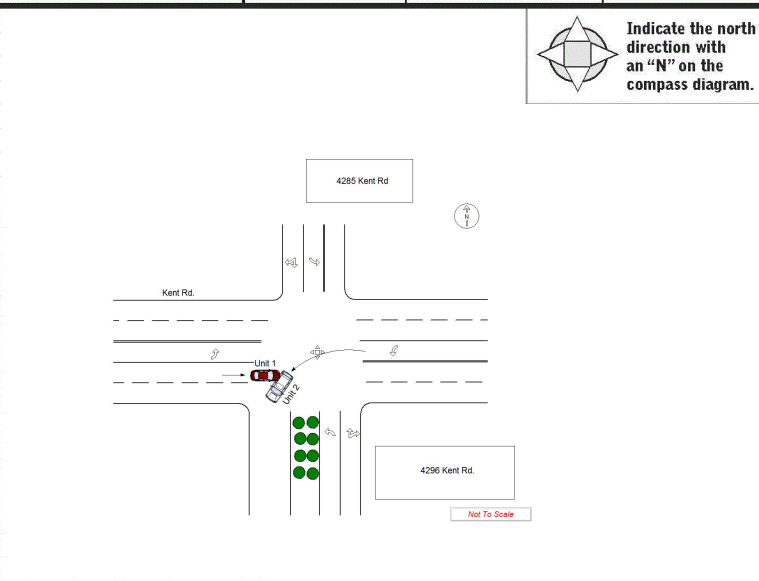

When the traffic signal turned yellow, Unit 2 failed to yield to the right of way when making a left turn, turning in front of Unit 1 causing Unit 1 to strike Unit 2.
