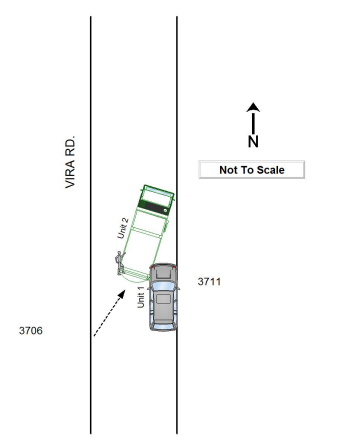
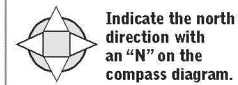

AFTER COMPLETE, UNIT #2 STARTED TRAVELING NORTH AGAIN BUT SWITCHED LANES FROM THE SOUTHBOUND LANE TO THE NORTHBOUND LANE. THE DRIVER DID THIS AT THE SAME TIME THAT UNIT #1 WAS TRAVELING NORTH AND UNIT #2 SIDE SWIPED**

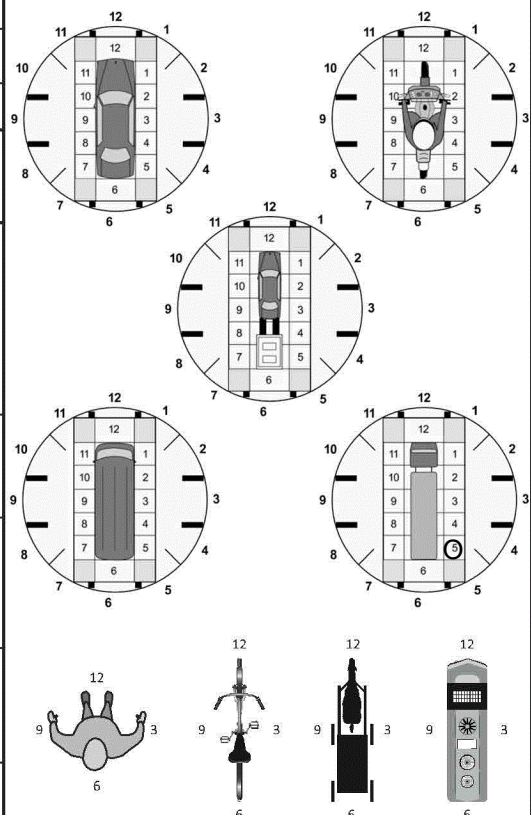
