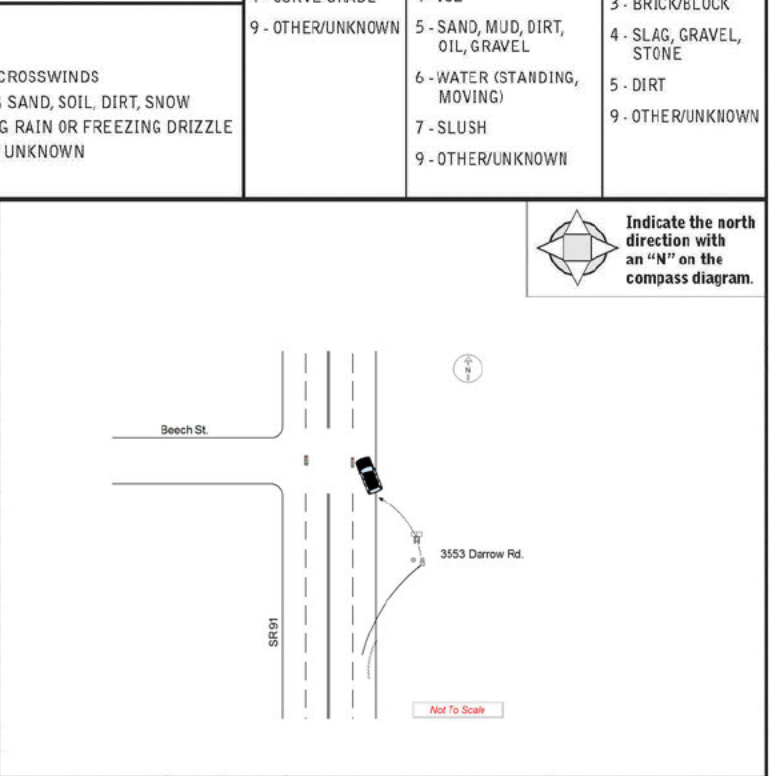

**Unit 1 was traveling north in the right lane on SR 91 approaching Beech St. Unit 1 lost control of the vehicle and swerved off the right side of the roadway to avoid a collision with the stopped vehicle's at the traffic signal. Unit 1 continued off the roadway striking a wooden post and a for sale sign before traveling back onto the roadway. This accident was captured on Stow PD Car 6 dashcam.**
