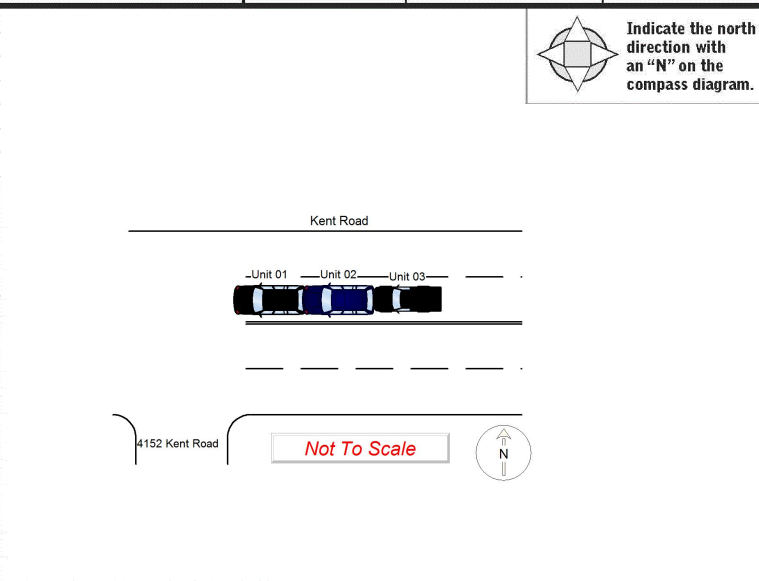

NARRATIVE

Unit 01 was traveling westbound on Kent Road in the inside lane, stopped in traffic to turn into 4152 Kent Road. Unit 02 was directly behind Unit 01, slowing to a stop. Unit 03 was directly behind Unit 02 and failed to maintain assured clear distance ahead, striking Unit 02. This impact caused Unit 02 to strike Unit 01.

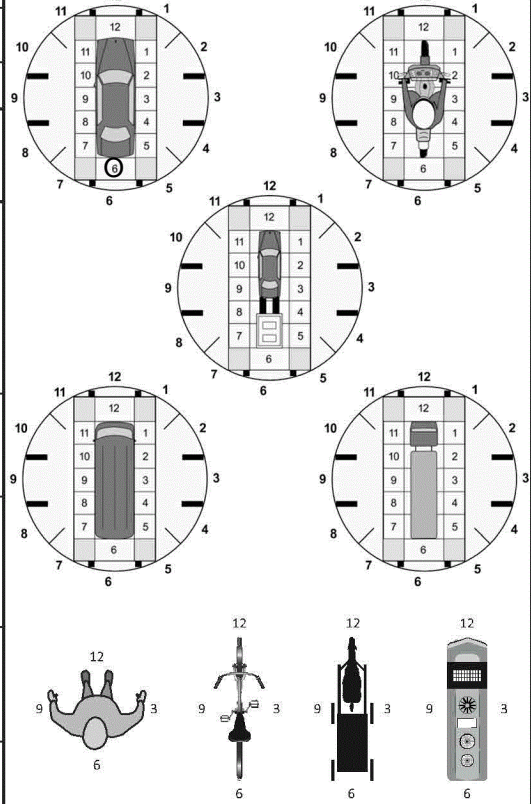

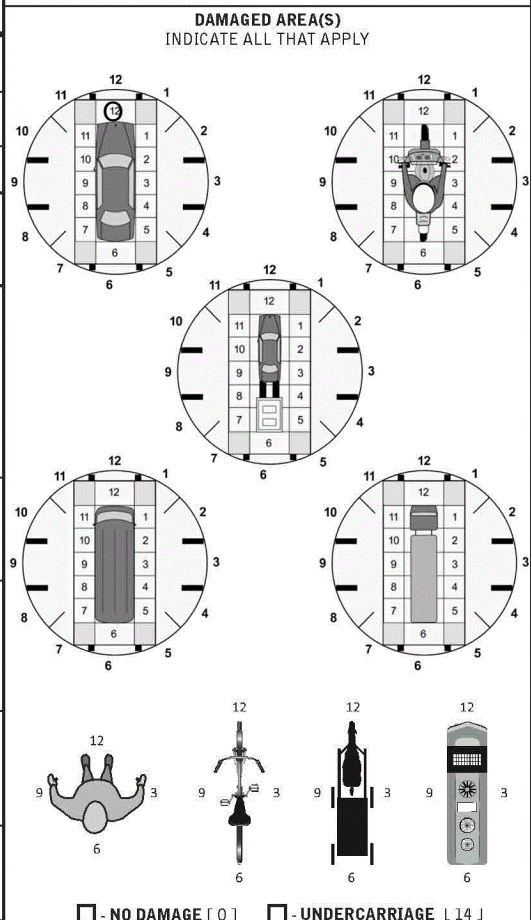

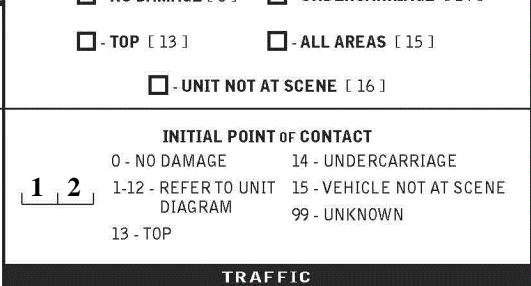
